

Distribution Center (DC) Information

HOW TO DO BUSINESS IN THE PHILIPPINES

The following information is specific to The Philippines for Distribution Center (DC) Operations. For more details, please see your Manual for Distribution Center Operations.

Signing Up New FreeLife Marketing Executives:

- All DCs must purchase memberships for new Marketing Executive sign-ups. These are treated as an inventory and reduced by Goji Global as used. (See manual for details.)
- The price of the membership fee includes a free gift of the Promotional Information Pack from FreeLife. (Available in English only.)
- Membership fee for the Philippines is \$17.50 USD plus shipping, handling, and taxes.
- Membership fees must be purchased in 6 units at a time.
- Membership fees may be purchased online at Gojiglobal.com or by giving your credit card number (VISA, or MasterCard) to a Goji Global Customer Service Representative.
- Follow the process flow chart in the Manual for applications.
- Promotional Information packs will be delivered when available directly to the Distribution Center to give out to new Marketing Executives. These will only be delivered with cases of Himalayan Goji Juice (HGJ). (No separate shipments.)

Order Placement for Distribution Centers:

- Orders for HGJ product must be in increments of 6 cases (i.e. 6, 12, 18, etc.).
- All orders from DCs are placed with the authorized Importer for the Philippines. The Importer is:

- Price of the products is in USD as follows to the Marketing Executives for PICKUP. The Distribution Center retains \$3.00 per case of the prices below to help offset their costs. Delivery of cases may be arranged with the Importer and is a separate charge.

ALL SALES ARE IN USD ONLY.

- ME Price per case of HGJ = \$165.50 USD
- DC cost for 6 cases of HGJ will total \$959.70 (\$162.50 per case)
- The \$3 difference between the ME price (\$162.50) and the DC price (\$159.50) is retained by the DC selling the case.
- PLEASE NOTE: This price includes 12% VAT (value added tax).
- Money for HGJ orders should be sent to the Importer in the following manner (please contact the Importer if you have a question):
 - Cash
 - Wire transfer to Importer Bank account
- All order and enrollment information sheet with names and addresses of those purchasing should be entered online with Goji Global in the Distribution Center back office for commission credit.

Delivery of Products to Distribution Centers:

- Orders may be picked up as soon as payment is received and confirmed. No goods may be picked up or shipped prior to receipt of payment.
- If product needs to be shipped to another location outside of the metro Manilla area or one of the islands then an additional shipping charge will be charged by the shipping company upon delivery of the product to the Customer.

Commission Payments via ATM Cards

All commissions are provided by FreeLife via ATM card to each Marketing Executive earning commissions. Your card will begin to be processed once FreeLife has been provided all required documentation (Marketing Executive Application, Birth Date, W-8BEN and Photo Identification) and when your commissions reach \$15 with FreeLife International. The card may take up to three weeks to process and the cost of the card (\$5) will be deducted from the commissions at that time. As a result you have NO upfront costs until you are ready to receive your commissions. The ATM card will also be charged a small monthly fee of \$3 directly by the processing company. ATM withdrawal fees will also apply depending upon the institution used.

Until you reach the level where your card will be issued, all commissions will be held on your account. No commissions will be lost. Commission payments are generated on or about the fifteenth (15th) of each month for commissions earned during the previous month. When the fifteenth (15th) falls on a weekend or holiday, the commission payments will be generated the following business day. When you are eligible to receive your first commission payment, there may be up to a 3-4 week delay until you receive your ATM card. This delay only applies to the first commission payment and is due to the processing time for the ATM card.

- You will receive your ATM card through your Distribution Center when your commissions are ready to be paid.
- Your PIN (Personal Identification Number) will be sent to you via your Distribution Center.
